



BONZA GAME FARM RULES

1. OBJECTIVE

The objective of these Rules are to ensure the control over company assets, the regulated use of the facilities, coordination of bookings and managing Bonza Game Farm as a conservation area.


2. WHO MAY MAKE USE OF THE FACILITIES ON BONZA GAME FARM?

- 2.1 Bonza Game Farm is available to all paid up Lime Acres Wildlife Club Members.
- 2.2 Lime Acres Wildlife Club Member's spouses, partners and dependent adult children are permitted to visit Bonza Game Farm without being accompanied by the family's main Lime Acres Wildlife Club Member. The main Lime Acres Wildlife Club Member will however still be responsible for any damages, misbehavior etc. caused by his/her family.
- 2.3 Finsch Diamond Mine employees that are not members of the Lime Acres Wildlife Club may only visit Bonza Game Farm if they are accompanied by at least one Lime Acres Wildlife Club Member.
- 2.4 The booking of facilities for company purposes, members and private parties is explained under clause 4 of these rules. A Lime Acres Wildlife Club Member must belong to the Lime Acres Wildlife Club for at least 3 months to qualify for Membership discount.

3. BONZA GAME FARM RULES

- 3.1 Lime Acres Wildlife Club Members and their guests may use Bonza Game Farm for game viewing, bird watching and other activities consistent with the aims of the Lime Acres Wildlife Club.
- 3.2 The Chairperson/Vice Chairperson or his/her designate must approve requests for night viewing (sunset to sunrise) but only if accompanied by a Lime Acres Wildlife Club Committee Member.
- 3.3 All motorized travel shall be restricted to the roadways at a speed of 30 km/h.
- 3.4 No person is permitted to drive around on Bonza Game Farm without a member/Spouse of a member present.
- 3.5 Only the main access roads are to be used for access by visitors making use of accommodation at Bonza Game Farm.
- 3.6 Demarcated areas for parking vehicles must be used, i.e., no parking on the grass / lawn in front of the chalets or Secretary Bird Lodge. A fine of R500.00 per vehicle will be issued.
- 3.7 Please take note that the game should never be disturbed, except during an authorised hunt/cull.

- 3.8 No firearms will be allowed on Bonza Game Farm, except in the case of approved culling operations, hunting and pest control.
- 3.9 No littering shall be tolerated on Bonza Game Farm. People visiting the facilities will be responsible for the removal of their litter/debris. A fine of R1000.00 will be payable by the person responsible for the booking should litter be found.
- 3.10 No loud music from either vehicles, chalets, huts, braai areas and “lapas” are allowed on Bonza Game Farm.
- 3.11 No matches or cigarette butts shall be discarded within Bonza Game Farm. Every smoker, proceeding on foot, shall always have a suitable receptacle on their person to discard of these items.
- 3.12 Fires may only be lit at the designated braai areas. Every precaution must be taken to avoid sparks from causing veld fires and fires are to be totally extinguished after use.
- 3.13 No portable braai equipment is allowed at Secretary Bird Lodge, including inside the lodge, on the front veranda or under the thatch roof behind the Lodge. The fire pit at the back of Secretary Bird Lodge is not a braai area and may only be used if the facility was booked.
- 3.14 No flora may be broken or removed. Firewood must be acquired from outside the property of Bonza Game Farm.
- 3.15 Persons entering or exiting Bonza Game Farm must ensure that the gate is securely close by means of the appropriate locks / access key card. Failure to set rule will automatically make these parties liable for the replacement cost of loss of any game animals. These parties will be denied further access to Bonza Game Farm. The replacement cost will be at the discretion of the Lime Acres Wildlife Club Committee. Ensure that the gate is closed when entering and exiting the Lime Acres Wildlife Club’s main gate.
- 3.16 The person who made the booking shall be responsible to ensure that the gates/doors are properly locked and that they leave all the facilities as neat and tidy as possible. All dirty dishes must be washed and packed away in chalets and huts or stacked neatly in the lodge, lookout point and lapa.
- 3.17 Lime Acres Wildlife Club Members who enter Bonza Game Farm for recreational visits shall ensure that the gates are always closed / locked.
- 3.18 No pets, with the exception of horses, are permitted within or near the boundaries of Bonza Game Farm.
- 3.19 No motorcycles and quad bikes are permitted within or near the boundaries Bonza Game Farm. Cycling is only permitted on Bonza Game Farm gravel roads.
- 3.20 All visitors shall:
- 3.20.1 Supply their own wood. No wood may be collected on the Bonza Game Farm.
- 3.20.2 Remove their own refuse/trash from inside and outside chalets/lodge.
- 3.21 Visitors are not allowed to remove furniture, equipment (especially the portable braai stands) or crockery and cutlery from any area on Bonza Game Farm. Should items that are listed on the inventory be missing the visitor shall be liable for the replacement cost.

- 3.22 The Lime Acres Wildlife Club Duty Member will be responsible for Bonza Game Farm vehicle and is permitted to transport his family/guests during his duty rounds. During official Wildlife Club events and educational trips, the vehicles will be available for game viewing. The vehicles will be made available to official events booked at Bonza Game Farm subject to duty requirements and availability of personnel and equipment.
- 3.23 Bonza Game Farm vehicles must be parked at the allocated site in their parking bays at Finsch Diamond Mine and the keys collected and signed out at Security.
- 3.24 Bonza Game Farm vehicles may only be used by Lime Acres Wildlife Club Committee Members in possession of an appropriate valid civilian driver's license.
- 3.25 Children shall always be accompanied by the Lime Acres Wildlife Club Member.
- 3.26 Non-members of Lime Acres Wildlife Club cannot visit or access Bonza Game Farm without being accompanied by a Member of the Lime Acres Wildlife Club. Lime Acres Wildlife Club Members are not permitted to give their access cards to any other person to have access to Bonza Game Farm. Please note that if this occurs, your membership will be suspended with immediate effect.
- 3.27 Fishing (catch and release) is permitted at allocated fishing spots and R100 per family per day must be paid before the date of fishing and proof of payment must be sent to the Lime Acres Wildlife Club Secretary on Lianie.Rule@petradiamonds.com during office hours from Monday to Friday. Fishing arrangements will not be accepted after hours. People found fishing must produce proof of payment.
- 3.28 Paid up Lime Acres Wildlife Club Members are permitted to drive and picnic over weekends and after hours at no cost, with the strict understanding that all refuse etc. is cleared afterwards. Non-members may only access Bonza Game Farm with a paid-up Lime Acres Wildlife Club Member.
- 3.29 All misappropriation of Bonza Game Farm facilities, load music from cars and facilities, vandalism, robberies, break-ins, misbehaving of guests, children not adhering to the Bonza Game Farm rules, medical emergencies, ~~in case of~~ fires, must be reported to Security at 053 385 2300/2250/2253.
- 3.30 No camping with tents, camping trailers or caravans are permitted on Bonza Game Farm.

4. FACILITY BOOKINGS

- 4.1 Bonza Game Farm accommodation bookings for Lime Acres Wildlife Club Members are subject to the following rules:
- 4.1.1 Lime Acres Wildlife Club Members may book one accommodation unit in their name at the Bonza Game Farm at the Lime Acres Wildlife Club Member rate.
- 4.1.2 Should a Lime Acres Wildlife Club Member wish to book a second accommodation unit for a friend to join them at the Bonza Game Farm, then the second accommodation unit may also be booked at the Lime Acres Wildlife Club Member rate. The Lime Acres Wildlife Club Member shall not allow their friend to be unaccompanied whilst on Bonza Game Farm.
- 4.1.3 Normal accommodation unit prices will be charged for the booking of three or more accommodation units by a Lime Acres Wildlife Club Member will be charged at the normal non- Lime Acres Wildlife Club Member rate.
- 4.2 Bonza Game Farm accommodation bookings for Non-Lime Acres Wildlife Club Member will be charged at the normal non- Lime Acres Wildlife Club Member rate.

- 4.3 All Bonza Game Farm Bookings must be made through the Lime Acres Wildlife Club Secretary, Lianie Rule (Lianie.Rule@petradiamonds.com) and are subject to availability. Bookings must be made during working hours from Monday to Thursday from 07:00 to 16:00 and Fridays from 07:00 to 13:00 via email or landline (053 385 3561). No bookings will be made after hours.
- 4.4 Maximum number of persons per accommodation unit is restricted to:
- 4.4.1 Olienhout Camp small hut – 4 persons
 - 4.4.2 Olienhout Camp large hut – 10 persons
 - 4.4.3 Feathers Camp chalet – 4 persons
- The person that books the facilities will take full responsibility for all persons present.
- 4.5 Bookings for Feathers Camp, Olienhout Camp and the butchery will be considered independently. Bookings made by Finsch Diamond Mine will always take precedence over any other booking. The following types of bookings are available:
- 4.5.1 Private bookings (Feathers and Olienhout Camp chalets, Secretary Bird Lodge, Old Lapa, Lookout Point).
 - 4.5.2 Functions (Secretary Bird Lodge, Old Lapa, Lookout Point).
 - 4.5.3 Game drives.
 - 4.5.4 Hunting trips.
- 4.6 Confirmation and payment of private bookings (non-members) shall be made no later than 3 days prior to the booking. Finsch Diamond Mine business accommodation requirements will receive preference and can result in short notice cancellation of bookings.
- 4.7 When Lime Acres Wildlife Club Members or non- Lime Acres Wildlife Club Members book accommodation and then cancel it within 3 days before actual reservation date, the confirmed reservation monies will not be refunded or amount payable will still be due.
- 4.8 Bookings for game drives are to be made a week in advance. Set times for game drives are as follows:
- 4.8.1 Saturdays: 07:00 & 17:00 in summer and 09:00 & 15:00 in winter.
 - 4.8.2 Sundays: 17:00 in summer and 15:00 in winter.
 - 4.8.3 Game drive will be +/- one and a half hour in duration depending on weather conditions.
- 4.9 The full amount due must be paid before you will be allowed to make use of the facilities.
- 4.10 The liability/waiver form must be completed at Security when the keys are collected before you will be allowed to make use of the facilities.
- 4.11 Only one person will be allowed to book the butchery at any one time. Lime Acres Wildlife Club Committee Members control keys to the butchery and chill rooms. Where animal carcasses originate from farms, other than Bonza Game Farm, are to be stored in the chill room or processed in the butchery, must be approved by the Chairman or Vice-Chairman of the Lime Acres Wildlife Club. A letter should accompany this from the farm where the animal carcass originated. Should one person book the butchery, he/she may agree to share the facilities with another person if the rules



contained in this document are adhered to. The person that books the facilities will take full responsibility for all persons present and leave the facilities clean and tidy for the next person.

- 4.12 The Lime Acres Wildlife Club does have self-catering spit braai facilities upon request. The person that books the spit braai equipment will take full responsibility for the use and cleaning of the equipment.

5. BOOKING APPLICATIONS AND PAYMENT

5.1 Booking applications

The Lime Acres Wildlife Club Secretary, Lianie Rule, will provisionally book the facility for the applicant pending payment of the full rental fee and completion of required forms. The Lime Acres Wildlife Club Treasurer will issue a receipt for any monies (cash) received.

5.2 Payment

- 5.2.1 If application is approved, arrange a convenient time to pay the facility fee and obtain a receipt or send proof of payment to the Lime Acres Wildlife Club Secretary, Lianie Rule (Lianie.Rulle@petradianonds.com).
- 5.2.2 Keys will only be available at Security after payment is received in full by Lime Acres Wildlife Club Secretary, Lianie Rule. All keys for the facilities must be signed out upon arrival and signed back in upon departure at Finsch Diamonds Mines Security by the person who made the booking, and that person will be responsible for the loss of keys.

6. LIME ACRES WILDLIFE CLUB CARETAKER

The Lime Acres Wildlife Club Caretaker will inspect the facilities for breakage and cleanliness before and after use.

Should the facilities not be clean or any breakage evident, the cost of cleaning and/or repairs will be invoiced and claim from the applicant as per the completed liability form received. Breakage invoices must be paid within 7 days of issuing of the Invoice and failure to pay will result in the blacklisting of the applicant.

7. INDEMNITY FORMS

Before keys are issued by the Lime Acres Wildlife Club Security, all visitors shall complete an indemnity form to safeguard the Company against any claims or legal action, should visitor/s be injured on Bonza Game Farm. It must be noted that all visitors enter Finsch Diamond Mine property at their own risk and that the company will not be responsible for any damage to vehicles, belongings being stolen or injury to persons.

8. BLACKLISTING OF VISITORS / LIME ACRES WILDLIFE CLUB MEMBERS

- 8.1 The Lime Acres Wildlife Club Committee has the right to blacklist any visitors or members to Bonza Game Farm who:
- 8.1.1 Do not comply with these Bonza Game Farm Rules.
- 8.1.2 Do not leave the facilities in a clean and orderly condition, i.e., leaving plastic chairs or any other furniture outside the chalets/huts or lodge/lapa/lookout point.
- 8.1.3 Do not leave the facilities in the same way they found them.

8.2 Blacklisting of visitors / Lime Acres Wildlife Club Members will be determined by a disciplinary hearing, which will be conducted in accordance with Finsch Diamond Mine Procedures.

- 2 I acknowledge that I shall participate in the activities voluntarily and at my sole and absolute risk and that Finsch Diamond Mine cannot exercise any control whatsoever over the negligent or wilful acts or omissions of other parties participating in the activities.
